- 3. Delegating further authority & powers to the Rights Issue Committee, which was formed at the Board meeting held on April 06, 2022;
- 4. Re-appointment of M/s. Sai Krishna & Associates, Practicing Cost Accountants as the Cost Auditor of the Company for the Financial Year 2022-23.
